INTELLIGENCE ALERT

STOLEN ARIZONA BLANK VEHICLE TITLES UPDATE

Since February 2002, over 24,604 blank Arizona Certificate of Title forms have been taken from Motor Vehicle Department or 3rd Party Vendor locations in Arizona, many taken during armed robbery incidents.



Control Number Located in Upper Right Hand Corner

- Arizona Certificate of Title is computer printed on 8 x 10 inch, security-featured paper.
- The Control Number is printed in red ink in upper right corner of document.
- The Control Number is not the MVD vehicle Title Number.
- The Certificate **cannot** be queried in NCIC by control number
- Since 2008 certificates bear an 8-digit Control Number instead of re-using 7-digit numbers

Any Arizona Certificate of Title listed above, may not be used as proof of ownership, is fraudulent if presented for any purpose and constitute possession of stolen property. ADOT/OIG will assist in prosecution of any criminal charges filed in connection with these stolen blank title forms. If you contact any individuals in possession of one of these documents, or have information regarding these stolen documents, please contact the nearest law enforcement agency as well as ADOT/OIG.
